Capon Valley Bank Scholarship

This scholarship is awarded in the sum of \$1,000.00 to be used by an individual selected by the Capon Valley Bank Scholarship Committee.

Criteria/Qualifications for consideration:

- 1.) Children, step-children, grandchildren and step-grandchildren of employees or directors of Capon Valley Bank, as well as employees of Capon Valley Bank are not eligible for the scholarship.
- 2.) The individual must be a student who might not otherwise be able to pursue a higher education without financial assistance.
- 3.) The individual must graduate from high school with a minimum GPA of 2.5.
- 4.) The individual must pursue a Bachelor's Degree at a certified junior college, college or university.
- 5.) The individual must complete the required application and submit other information (if requested) to the High School Guidance Counselor by May 1st.
- 6.) The individual must submit with the application, a narrative in business letter form, typed and double spaced addressing the following:
 - A. Reason for continuing education; why a certain institution or major was selected
 - B. Personal goals; both short and long term
 - C. Brief history of school activities including clubs, extracurricular involvements, etc. as well as personal accomplishments and honors while attending high school
 - D. Brief history of civic/church activities
 - E. Brief history of work experience (paid and/or voluntary)
 - F. Name two major influences in your life and tell why and how they influenced you
 - G. Explain why this scholarship is important to you

***The award will be in the form of a check, made payable to the college or university to be used as a credit toward tuition and expenses. It will be awarded as \$500.00 the first semester and \$500.00 the second semester of college. If the awarded individual does not present a Letter of Acceptance by August 1st of the year awarded, the award may be given to another qualifying individual.
